

# SHERIFF'S FEES

Upon reviewing the increasing labor rate for employees, the increasing costs of office supplies, vehicle maintenance, fuel fees, and the increasing volume of service papers received per years since 2007, the Minidoka County Sheriff's Office has implemented, through resolution number 07-05 and 2017-07-24 before the Board of County Commissioners the following increases of civil service fees:

For serving summons and complaint .....	\$30.00
For serving every notice, rule or order.....	\$30.00
For serving a subpoena for each witness summoned .....	\$30.00
For copy of and making a return on any Writ, process or other papers served or not served where attempts were made .....	\$30.00
Return of service received but not attempted and Recalled .....	\$20.00
For serving an attachment on property or levying an Execution .....	30.00
For making and issuing a keeper's receipt .....	\$10.00
For taking a bond or undertaking any case .....	\$30.00
For making and posting notices and advertising property for sale on attachment or execution .....	\$15.00
For serving a writ of possession, assistance or restitution that is uncontested.....	\$30.00
For serving a writ of possession, assistance or restitution that is contested .....	\$30.00 + Deputy wages/hour @ location
Moving and storage costs .....	Actual costs
Postage Fees.....	Actual costs
For commissions for receiving and paying over money on execution or other process when land or personal property has been levied on and sold:	
On the first \$1,000.00.....	3.0%
On all sums above that amount.....	2.0%
But in no case of sale of real estate shall his commission exceed the sum of.....	\$100.00

When the amount of such sale is credited on the debt  
and no money is transferred..... \$100.00

For commissions for receiving and paying over  
money on execution without levy, or where land  
or good are not sold:  
On the first \$1000.00..... 2.5%  
Over the sum of \$1000..... 2.0%

But not to exceed in any case ..... \$75.00

For executing a certificate of sale, exclusive of the  
filing and recording of same ..... \$20.00  
For drawing and executing a sheriff's deed..... \$20.00

For traveling to serve any summons and complaint, or any  
other process by which an action or proceeding is commenced,  
notice, rule, order, subpoena, venire, attachment on property,  
to levy and execution, to post notice of sale, to sell property,  
under execution or other order of sale, or execute an order  
of arrest, or order for the delivery of personal property, writ  
of possession or restitution, to hold inquest or trial or right  
of property, for each mile actually and necessarily traveled  
for the first twenty-five miles no charge shall be allowed, and  
for any miles traveled over twenty-five miles, even if process  
is not served, the following shall be allowed, **in going only**..... \$0.65/mile

For copy of and making an interim return on a continuing  
garnishment to show disbursement of moneys held by the Sheriff..... \$ 7.00
